Further, I understand that if neither of these plans is approved, I will be given the opportunity to terminate my enlistment.
3. With the consent of my parents or guardian, I am prepared, when required to do so, to enter into one or the other of the following agreements regarding my service in the Navy (depending upon which aviation training plan is approved):
 - (a) If selected under PLAN I, to agree to remain in the Navy for a period of five years from the date of entry into the college training phase of the program, unless sooner released by the Navy Department; OR,
 - (b) If selected under PLAN II, to agree, at the time of transfer to flight training following college training, to remain on active duty for four years from the date of entry into flight training, unless sooner released by the Navy Department.

4. I am unmarried and agree to remain unmarried until completion of training and acceptance of appointment as a commissioned officer, unless sooner released by the Navy Department.
5. I CERTIFY that I have not previously failed flight training in the Army or Navy.
6. I understand that any violation of the agreements herein contained or any falsification of material facts in my application will result in separation from the Naval Aviation Preparatory Program.
